Silent and Live Auction Absentee Bid Form

Thank you for your interest in placing an absentee bid in the LIVE and/or SILENT auction. This form is for people who want to participate in the auction but will not be with us in Lander on September 23.

Schedule:

- Bidding for the SILENT and LIVE auction is available online until September 22 at midnight.
- The SILENT auction will re-open at the Lander Community Center on September 23 at 7:00 a.m. and close on September 23 at approximately 7:30 p.m.
- The Live Auction will commence at about 7:00 p.m. and will last about 15 minutes.

Process:

To place an ABSENTEE BID for a SILENT auction item(s) on September 23

1. Complete the ABSENTEE BID FORM below indicating your maximum bid.

To place an ABSENTEE BID for a LIVE auction item on September 23, there are two options:

1. Complete an ABSENTEE BID FORM indicating your maximum bid.
2. Complete the ABSENTEE BID PHONE FORM. This allows you to participate in the LIVE auction by phone. It is simple: indicate a phone number where a representative of the Wyoming Outdoor Council can phone you on September 23 at 6:55 p.m. The representative will follow your instructions LIVE and thereby allow you to participate as if you were in the room.

Absentee Bid Terms and Conditions

1. I understand that I must be at least 21 years old to bid.
2. By submitting this form, I authorize a Wyoming Outdoor Council representative to place bids on my behalf for the above item(s) up to and including the maximum bid specified above.
3. I understand that my bid will be executed at the lowest prices allowed by reserves and other bids.
4. I understand that this representative will place bids at the increments set by the auctioneer at the live auction, and the pre-determined increments at the silent auction.
5. If my absentee bid is the highest made, I will win the bidding and I authorize my credit card above to be charged in that amount on the night of the auction.
6. I understand that I will pay all shipping costs.
7. I understand that I will receive confirmation of the winning bid no later than three business days following the event.
8. I understand that in the event that two absentee bids tie for the same item, the absentee bidder who submitted their absentee bid first will win the item.
9. I understand that my submission of the Absentee Bid Form is final.
10. The Wyoming Outdoor Council is not responsible for failure or other inadvertent errors relating to execution of my bids.
