#### **BILLS WE SUPPORTED:**

- HB 1 – General government appropriations. **PASSED.**

- HB 12 – Shed antlers and horns. **FAILED.** (but is largely covered in HB 38)
- HB 26 – Limited mining operations — amendments. **PASSED.**
- HB 28 – Regulation of shed antler and big game horn collection. **PASSED.**
- HB 32 – EQC amendments. **PASSED.**
- HB 99 – Wyoming public lands day. **PASSED.**
- HB 228 – Highway and wildlife safety studies and improvements. **FAILED.** *Interim topic.*
- HB 231 – Net metering amendments. **FAILED.** *Interim topic.*
- HB 305 – Land access study. **FAILED.**
- SF 29 – Cease and transfer priority list. **PASSED.**
- SF 57 – Public records. **PASSED.**
- SF 77 – 2019 large project funding (Wyoming Wildlife and Natural Resource Trust Funding). **PASSED.**
